

Privacy Policy – English edition 11/09/2020

1. General

This personal data protection policy aims to inform you of our practices and the conditions under which LA MAISON DE VERRE (hereinafter “NAME”, the “Company” or “us”) collects, uses or stores data of a personal nature (hereinafter the “Data”) that you are required to provide us through our platform (the “Platform”) accessible from the website <https://www.lamaisondeverre.fr>.

This policy sets out how we handle the personal data that we collect and that you provide to us. We invite you to read this document carefully to know and understand our practices regarding the processing of your personal data that we implement, and inform you that the consultation and / or use of our site necessarily entails the acceptance of the this Policy.

2. What personal data do we collect and how are they collected?

Depending on the nature and purpose of your interaction with LA MAISON DE VERRE, (newsletter subscription, filling out contact forms, making purchases, as well as during any telephone exchanges, etc.) we may collect the following data:

The data you send us directly when:

- You fill out forms (such as the newsletter subscription form)
- Create an account to place an order
- You contact us, whether by phone, email or any other means of communication, or when you send us a request.

The data we collect automatically when:

- You connect to our services by using the social network functionalities made available to you. LA MAISON DE VERRE will have access to some of the data (in particular, your first name, last name, photograph, e-mail address and number of Facebook friends) from your account on the said social network in accordance with the general conditions of use of the network social concerned. We are also likely to collect some of your Personal Data when you interact with features of these social networks, such as "Like" features.
- You visit our site. We are likely to collect, in accordance with the applicable legislation and with your agreement, if applicable, information relating to the devices on which you use our services or the networks from which you access our services, such as in particular your IP addresses, data connection, types and versions of

internet browsers used, types and versions of your browser plugins, operating systems and platforms, data concerning your browsing journey on our Platform, in particular your journey on the various URL pages of our Platforms, the content you access or view, search terms used, download errors, length of time certain pages were viewed, your device's advertising identifier, interactions with the page as well as any phone number used to contact us. Among the technologies used to collect this information, we use cookies in particular.

3. Who collects your personal data and with whom is it shared?

LA MAISON DE VERRE is responsible for the processing of personal data and will make decisions regarding the purposes and methods of processing the data and the instruments to be used, also including those used in the context of security measures.

In addition, in the context of our activity, and for external processing needs, personal data may be communicated to external companies to manage the site and the services. Thus, your payment data is transmitted to our payment service providers and to the bank account-keeping establishments in the context of carrying out transactions related to your purchases and the management of marketing operations.

The latter are bound by contractual obligations to respect the confidentiality of the Data and to use them only for the purposes for which we transmit them.

Finally, we are also likely to disclose your Data:

- to comply with any legal mandate, law or legal process, including governmental and regulatory requests;
- if we believe that the disclosure is made necessary or adequate in the context of the protection of the rights, property or safety of LA MAISON DE VERRE, its customers or other stakeholders. Said disclosure includes exchanging information with other businesses and organizations for the purposes of fraud and counterfeit protection.

Links to third party sites

The Site may contain links to various social networking platforms managed on third party servers, by people or organizations over which LA MAISON DE VERRE has no control.

Therefore, we can in no way be held responsible for the way your Data will be stored or used on the servers of these third parties.

We advise you to read the applicable Data protection policy of each third-party website that you access through our Site in order to assess the way in which your Data will be used.

4. What do we use your data for?

Your personal data is collected and processed for purposes strictly related to the use of the website and its services, following registration on the site and the purchase of items.

Your personal data may also be used in other processing operations under terms compatible with these objectives. Your personal information will be processed in particular for the following purposes:

- execute the sale concluded between you and us and provide you with the information and services requested;
- send you, in accordance with the applicable legal provisions and with your agreement when required by law, marketing, advertising and promotional messages and information relating to the use of our services, or suggest and advise you on goods or services that may be of interest to you. We may also use your data to send you advertising messages that may be of interest to you on social media platforms or third party sites. If you would like more information on this subject, we invite you to read the contractual documents of these platforms;
- provide you with all the information concerning the services of LA MAISON DE VERRE and the purchase of items on <https://lamaisondeverre.fr> by e-mail, SMS or any other means of communication;
- provide you with information on Internet browsing, the compatibility of your browser, as well as the consultation and loading of the pages of <https://lamaisondeverre.fr> to help us preserve a healthy and secure environment on our Platform;
- Respect our rights and obligations stipulated in contracts concluded with users as well as for any other legal purpose.

We also use cookies or tracers in the context of marketing activities:

in order to improve your user experience, in particular by:

- allowing our site to recognize your material, so you will not have to provide the same information several times in order to perform the same task;
- recognizing the username and password that you have already provided so that you do not have to enter them on each web page that requests it.

analyze traffic and data on our site in order to:

- measure the number of users, thereby making it easier to use and ensuring their ability to respond quickly to your requests;

- estimate browsing habits and speed up your searches;
- help us understand how you use our site in order to improve it.

5. What are the security measures for the protection of your data?

We have implemented security measures to minimize the risk of destruction or loss, even accidental, of this data, consultation or processing of data not authorized or not in accordance with the purposes of collection indicated in our Policy of Confidentiality.

Given the inherent characteristics of the Internet, it is however impossible for us to guarantee that the security measures put in place for the protection of the website and for the transmission of data on www.LA MAISON DE VERRE.paris limit or exclude any risk of unauthorized access or loss thereof.

We cannot be held responsible for any failure to respect the confidentiality settings or the security measures in place on our Site.

We advise you to equip your computer with software tools ensuring the protection of the transmission / reception of your network data, both in input and output, (such as an up-to-date antivirus system) and to make sure that your Internet service provider has taken the necessary measures to guarantee the security of network data transmission (such as, for example, by means of firewalls and spam filters).

6. What are your rights?

You have the right, at any time, to ask LA MAISON DE VERRE for confirmation of the existence or not of personal data concerning you, even if they have not yet been recorded.

In addition, you have the right to receive from LA MAISON DE VERRE information on the origin of your personal data, the means used for their processing and the purposes thereof, the reasoning behind any processing of data carried out using electronic tools, detailed information on the holder and data processors, as well as an indication of the subjects or categories of subjects to whom your personal information may be disclosed or who may have access to it , as, for example, managers or subjects responsible for processing.

This information is contained in part in our Privacy Policy; to find out more, contact us in the manner indicated in article 8 below.

You are entitled at any time to obtain from LA MAISON DE VERRE:

- updating, rectification or, if you wish, integration of your personal information;

- the deletion, conversion to an anonymous format or blocking of your personal information (which has been the subject of unlawful processing), including data that does not need to be kept for the purposes for which it was been collected and then processed;

- confirmation that the operations carried out in accordance with the above paragraphs have been notified (with the content of said operations) to those to whom the information has been disclosed or communicated, except in situations where this is impossible or when the means employed are clearly disproportionate to the protection of rights.

You have the right to object, in whole or in part:

- for legitimate reasons, to the processing of your personal information, even if this processing respects the purposes for which it was collected;

- the processing of your personal data for advertising or direct marketing purposes or for the purpose of carrying out marketing studies or commercial communication actions.

You also have the right to define guidelines relating to the fate of your Data in the event of death.

Before responding to your request, we may verify your identity and ask you to provide us with more information to respond to your request.

We will do our best to respond to your request within a reasonable time and, in any event, within the time limits set by law.

7. Links to other websites and social networks

Our Platform may occasionally contain links to the websites of our partners or third-party companies.

LA MAISON DE VERRE does not control or carry out surveillance operations on such sites and their content. LA MAISON DE VERRE cannot be held responsible for the content of these sites and the rules adopted by them, including with regard to the protection of your privacy and the processing of your personal data during navigation operations.
